**Note 1** - Pursuant to Proviso 72.68 of the FY06-07 Budget, the first \$450,000 collected shall be transferred to the Prosecution Commission. Any remaining funds shall be transferred to the Judicial Department.

**Note 2** - Pursuant to Proviso 73.2, of the FY06-07 the State Treasurer may retain the actual cost associated with the collection of this surcharge not to exceed \$40,000.

**Note 3** - Pursuant to Proviso 73.2, of the FY06-07 the first \$3,985,600 (amount appropriated for Judicial Circuits State Support) will be transferred as follows: \$2,989,200 (75%) to Highway Patrol Division; \$996,400 (25%) to SC Judicial Department

**Note 4** - Pursuant to Proviso 72.80 of the FY06-07 Budget, the first \$10,900 collected shall be transferred to the State Auditor to fund audits and the second \$2,000 to fund training.

**Note 5** - Pursuant to Proviso 72.80 of the FY06-07 Budget, the first \$136,600 collected shall be transferred to the State Auditor to fund audits and the second \$5,000 to fund training.

**Note 6** - Pursuant to Proviso 72.80 of the FY06-07 Budget, the first \$102,500 collected shall be transferred to the State Auditor to fund audits and the second \$3,000 to fund training.
