Note 1 - Pursuant to Proviso 72.65 of the FY07-08 Budget, the first \$450,000 collected shall be transferred to the Prosecution Commission. Any remaining funds shall be transferred to the Judicial Department.

Note 2 - Pursuant to Proviso 73.2, of the FY07-08 the State Treasurer may retain the actual cost associated with the collection of this surcharge not to exceed \$40,000.

Note 3 - Pursuant to Proviso 73.2, of the FY07-08 the first \$3,985,600 (amount appropriated for Judicial Circuits State Support) will be transferred as follows: \$2,989,200 (75%) to Highway Patrol Division; \$996,400 (25%) to SC Judicial Department

Note 4 - Pursuant to Proviso 72.75 of the FY07-08 Budget, the first \$10,900 collected shall be transferred to the State Auditor to fund audits and the second \$2,000 to fund training.

Note 5 - Pursuant to Proviso 72.75 of the FY07-08 Budget, the first \$136,600 collected shall be transferred to the State Auditor to fund audits and the second \$5,000 to fund training.

Note 6 - Pursuant to Proviso 72.75 of the FY07-08 Budget, the first \$102,500 collected shall be transferred to the State Auditor to fund audits and the second \$3,000 to fund training.
