### Instructions for filling in State Treasurer's Court Revenue Remittance Form

***Fines, Fees, Assessments and Surcharges DUE TO THE STATE TREASURER:***

F	Family Court Alimony/Child Support Fee	Enter 44% of collections.

***Assessments and Surcharges (other than DUI) RETAINED BY YOUR OFFICE:***

DD	General Sessions Court Assessments (other than DUI)	Enter 35.35% of collections.
EE	Magistrate Court Assessments (other than DUI)	Enter 11.16% of collections.
FF GG	General Sessions and Magistrate Surcharges (other than DUI SURCHARGES). \$100 per conviction in General Sessions, and \$25 per conviction in Magistrate and Municipal Courts.	Enter 100% of collections.
HH	Total Retained For Victim Services	Enter total of Column 5 lines DD through GG. Notes Below.

**Note:** These funds are to be accounted for by the local jurisdiction in a separate account specifically for Victims Services and reported for information only to the State Treasurer.

**Note:** Transfer cases should be assessed at the rates and reported in the line applicable to the court from which the case was transferred.

***Reports are due no later than 5:00pm on the 15th of the month following collection. If interested in ACH, contact the State Treasurer's Office no later than the 15th of the month.***
