**118.19.** (SR: Nonrecurring Revenue) (A) The source of revenue appropriated in subsection (B) is nonrecurring revenue generated from the following sources:

(1) \$1,023,777,259 from Fiscal Year 2020-21 Contingency Reserve Fund;

(2) \$2,853,646,014 from Fiscal Year 2021-22 Projected Surplus;

(3) \$16,832,497 from Fiscal Year 2021-22 Debt Service in Excess Obligation;

- (4) \$53,898,508 from Litigation Recovery Account;
- (5) \$525,000,000 from Savannah River Site Litigation; and

(6) \$100,000,000 from Estimated Excess Debt Service above Projected Expenditures.

Any restrictions concerning specific utilization of these funds are lifted for the specified fiscal year. The above agency transfers shall occur no later than thirty days after the close of the books on Fiscal Year 2021-22 and shall be available for use in Fiscal Year 2022-23.

This revenue is deemed to have occurred and is available for use in Fiscal Year 2022-23 after September 1, 2022, following the Comptroller Generals close of the states books on Fiscal Year 2021-22.

# Under the last section titled "<u>Please Explain How These Funds Will Be Used to</u> <u>Provide a Public Benefit</u>"

Research indicates the greatest risk factors for homelessness among Veterans is a lack of support and social isolation after discharge. Roughly 1 in 5 Veterans resides alone. The importance of PSO Inc. is to provide a social network for those who are experiencing a crisis or need temporary assistance and to expand aid to homeless Veterans in the community by connecting them to other agencies and organizations for additional supportive services. Since December 2012, PSO Inc. aims to make a positive impact in the lives of Active-Duty service members and Veterans experiencing food insecurity, homelessness, and financial crisis. Utilizing volunteers as foot soldiers, PSO Inc. provides necessities, including clothing, blankets, sleeping bags, tents, bus passes, gas cards, personal hygiene products, and food to local service members and Veterans in need.

Service members encounter financial hardships unique to the military culture. Enlisting and leaving family support systems at a younger age than the majority of the general population, higher cost of living associated with frequent moves or changes in station/location, deployment(s), and opportunities for stable spousal employment are a few examples of the unique hardships that impact our military members. Through in-depth assessments to understand the root issue of a financial emergency, we can connect service members and their families to additional resources to address financial literacy issues including setting financial goals, creating a budget, assisting with major purchases, and financial counseling for credit concerns while offering emergency financial assistance to service members, eligible family members, and survivors in need at the moment.

To combat homelessness and food insecurity for Veterans and service members in the local tri-county community, PSO hosts multiple events in the area focused on connecting the homeless with immediate hunger relief and supportive services. One example of how Project Street Outreach benefits the public is our Annual Community Thanksgiving Meal Distribution event. In 2021, over 400 Veterans and service members attended our Annual Community Thanksgiving Meal Distribution Event. PSO was able to distribute pre-packaged Thanksgiving dinner meal kits to those experiencing food insecurity and offered hot meals to the homeless in addition to connecting them to supportive services that could offer VA benefits counseling, food assistance programs, emergency shelter information, alcohol and drug abuse services, educational and employment services, and transitional housing.
