Note 1 - Pursuant to Code Section 8-21-320(1), effective July 1, 2009, the first \$450,000 collected shall be transferred to the Prosecution Commission. Any remaining funds shall be transferred to the Judicial Department.

Note 2 - Pursuant to Code Section 14-1-212(B)(1), the State Treasurer may retain the actual cost associated with the collection of this surcharge not to exceed \$40,000.

Note 3 - Pursuant to Code Section 14-1-210(B), the first \$15,260 collected shall be transferred to the State Auditor to fund audits, and Code Section 14-1-210(E), the second \$2,000 shall be transferred to the STO to fund training.

Note 4 - Pursuant to Code Section 14-1-210(B), the first \$191,240 collected shall be transferred to the State Auditor to fund audits, and Code Section 14-1-210(E), the second \$5,000 shall be transferred to the STO to fund training.

Note 5 - Pursuant to Code Section 14-1-210(B), the first \$143,500 collected shall be transferred to the State Auditor to fund audits, and Code Section 14-1-210(E), the second \$3,000 shall be transferred to the STO to fund training.
