A major function of the agency is to carry out federal programs, which account for approximately 70% of its funding. During the year, the federal government announced plans to significantly reduce funding for, or to eliminate, many of these programs. In addition, federal funding had been significantly delayed throughout the year, creating cash flow challenges. In view of this situation, the agency determined it would be irresponsible to take on debt for an expansion, which could be made unnecessary, until the federal situation is clarified.
