In Q4 of 2024-2025, minor ongoing expenses for project management, outreach, and a library pilot project were accompanied by a contractual expense to support planning for strategically leveraging the intial state funding award, of which approximately \$189,750 remains at the end of the fiscal year. These remaining funds will be applied to continued activities in support of CORE SC's mission and public purpose in accordance with organizational and state priorities, which may include additional seed grants/project investments, competitive awards, and education/outreach activities.
